Perpetual Name Recognition and other Major Gifts:

Permanent Naming of the Cultural Hall and Cultural Center in the name of an Individual or Family:

Requirement is a commitment **of 1 million dollars** over next 10 years or as one time donation. The individual or family will have their name on the hall and all cultural events will have their name – Indian Cultural Center presents.

1. Naming of **the Dining Hall** in an individual's or family's name: Requirement is a total commitment of \$250,000.00 dollars over next five years.
2. Naming of **the Kitchen Hall** in an individual's or family's name: Requirement is a total commitment of \$150,000 dollars over the next 5 years.
3. **Founding donor** with a seat at the current board of the India Heritage Foundation: Requirement is a total commitment of \$100,000 dollars over the next five years.
4. Permanent recognition as a **Leadership Donor** of the I.H.F.: Requirement is a pledge of \$10,000 over next two years. This can also be added to any above Perpetual Naming Gift.
5. Permanent life member of our temple **and major donor** to the India Heritage Foundation Requirement is a total commitment of \$5000 dollars over next two years.
6. **Supporter** of the India Heritage Foundation: Commitment of \$1000 dollars each year for the next five years.
7. **Enroll** in automatic monthly donation plan(Forms are on web-site or any board member will send you)

A commitment does not need to be cash only. A gift of a vehicle, boat, house, IRA or appreciated stocks and part of life insurance proceeds can be committed.

A will or trust can be established or amended to include The India Heritage Foundation; this may result in a tax favorable situation for your family; please consult your accountant for full details. Other avenues of wealth transfer such as a Charitable remainder trust or Charitable lead trust are excellent methods in which one can transfer assets to their family as well as committing to the India Heritage Foundation and establishing perpetual name recognition for that individual or family.
